Families choosing Option 3 or 4 who are not already registered with FACTS for regular tuition payments will receive, by mail, a FACTS Tuition Agreement Form. **A non-refundable registration fee of \$25.00 per family for weekly users, must accompany the completed registration and payment agreement form.** This agreement must be completed and returned to the MCA business office within one week of receiving it.

- OPTION 1 Full payment of tuition** by October 1, 2009. A bill will be mailed and payment will be made directly to the school; no discount will be applied. Payments must be made by cash or check; credit cards and/or debit cards cannot be accepted.
- OPTION 2 Two equal semester payments** by October 1, 2009, and January 1, 2010. A bill will be mailed and payments will be made directly to the school; no discount will be applied. Payments must be made by cash or check; credit cards and/or debit cards cannot be accepted.
- OPTION 3 Automatic monthly payments through the FACTS Tuition Management Program.** Payments are automatically transferred from a checking or savings account on the 5<sup>th</sup> or 20<sup>th</sup> of each month from October through May. There is a non-refundable annual enrollment fee of \$38.00 per family, charged through FACTS, to participate in the monthly payment plan.
- OPTION 4 Credit card payments through the FACTS Tuition Management Program.** Payments are charged to your MasterCard, American Express, or Discover Card on the 5<sup>th</sup> or 20<sup>th</sup> of each month from October through May. There is a non-refundable annual enrollment fee of \$38.00 per family, charged through FACTS, to participate in the monthly payment plan. In addition to the enrollment fee, each payment will incur a credit card convenience fee.
